“Fees and Services Bylaw”

Being a bylaw of the Village of Alliance, in the Province of Alberta, providing for the establishing rates and charges for the provision of certain goods and services by the Village of Alliance.

WHEREAS pursuant provisions to the Municipal Government Act, RSA 2000, and amendments thereto Council may fix charges for the fees and services listed in the attached schedule;

AND WHEREAS the Village of Alliance receives requests for the provision of such fees and services

NOW THEREFORE, the Municipal Council of the Corporation of the Village of Alliance, duly assembled in council, enacts as follows:

- 1) TITLE: This bylaw shall be known and may be cited as the “Fees and Services Bylaw”.
- 2) The rates and charges contained in the attached Schedule “A” such schedule forming part of this Bylaw, shall be the rates and charges in effect for the provision of such goods and services stated.
- 3) All previous rates for Goods and Services as delivered to the Community and NOT noted in this bylaw shall be deemed not changed and adjusted by Council and shall remain intact for those Goods and Services as delivered to the Community.
- 4) Bylaw 2015-04 is hereby rescinded.

This Bylaw shall come into full force and effect on the date of the third and final reading.

READ a first time on this 13th day of September 2018.

READ a second time on this 13th day of September 2018.

Given UNANIMOUS consent to go to third reading on this 18th day of October 2018.

READ a third and final time on this 18th day of October 2018.
