

## **Bylaw 2015-04 Fees and Services Bylaw**

BEING a bylaw of the Village of Alliance, in the Province of Alberta, providing for the establishment of General Fees and Services for Goods and Services as delivered to the Community;

PURSUANT TO provisions of the Municipal Government Act, RSA 2000, Chapter M-26, and amendments thereto;

WHEREAS it is expedient for the Council of the Village of Alliance to enact a bylaw that establishes and maintains the General Fees and Services for services rendered within the Village of Alliance;

NOW THEREFORE, the Council of the Village of Alliance establishes the following rates for Goods and Services delivered to the Community, and enacts as follows:

1. TITLE: This bylaw shall be known and may be cited as the "Fees and Services Bylaw".
2. All previous rates for Goods and Services as delivered to the Community and as noted in this bylaw will be revoked and replaced by the following rates for Goods and Services as delivered in the Community.
3. All previous rates for Goods and Services as delivered to the Community and NOT noted in this bylaw shall be deemed not changed and adjusted by Council and shall remain intact for those Goods and Services as delivered to the Community.
4. Fee structure shall be:

### **A. WATER, SEWER, AND GARBAGE SERVICE CHARGES:**

All charges for water, sewer and garbage shall be as per the Utility Bylaw currently in effect.
