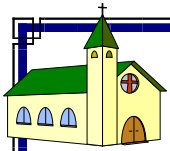
- ▶ \$20/ full pick-up load

- ☞ Alberta Arts Days will be celebrated Sept. 30 to October 2. This year we have decided to showcase some of our musical talent. The venue will be the Commercial Hotel. Join us for a musical "Jam" session on Sunday, Oct. 2, from 1 PM to 4 PM. Come, take part, or just enjoy an afternoon with other music lovers.
- ☞ Our Museum enjoyed hosting the recent museum tour. Thanks to the Museum Board for taking part in this interesting day.
- ☞ Some of our residents enjoyed the Trail of the Buffalo Ambassador Tour to Delia. These tours are held twice a year so that we can learn about the treasures of other communities. Delia has an impressive solar panel display that provides enough power to operate their water treatment plant and to sell a little extra each month into the power grid.

COUNCIL NOTES

At the regular meeting of council in August the following items were dealt with:

- ☞ Bids for sidewalk work were reviewed. QS Concrete was chosen to do one block of sidewalk on Main Street. This will be the west side from the Commercial Hotel to AG Hardware. Work is scheduled for mid-September. Plans are to do the rest of Main Street as funds are available over the next year or two. It will be done in stages so that the whole block is not torn up at one time.
- ☞ Since the Lion's Club has wound up it's business, the care and keeping of the Sports Grounds has returned to the Village. We thank the Lion's club for their many contributions to maintaining and keeping up the grounds for so many years. Council set a rate of \$50/day for anyone wishing to use the camp kitchen facility.
- ☞ The regular meeting of the Fire Department will be held at 8 PM on Sept. 7. Anyone who has a pager, but is not active on the department is asked to return it to the Fire Hall or the Village Office before that date, as we need to ensure that all active members have pagers and that we have an accurate inventory. Anyone who may be interested in being part of the department is also encouraged to attend this meeting.
- ☞ Our contract for assessment services with Wainwright Assessment Group was extended until July 31, 2014.
- ☞ The arena construction is progressing well. Tenders went out for the construction of the lobby and dressing rooms, etc, the electrical, mechanical and plumbing. Deadline for them to be in is 2 Pm on September 7, at which time the Building Committee will select the winning bids and the next stage of work will be ready to get underway.
- ☞ Public Auction is scheduled for September 14 at 1 PM. See that advertisement on the next page.

Each parcel will be offered for sale, subject to a reserve bid and to the reservations and conditions contained in the existing certificate of title. The land is being offered for sale on an "as is, where is" basis, and the Village of Alliance makes no representation and gives no warranty whatsoever as to the adequacy of services, soil conditions, land use districting, building and development conditions, absence or presence of environmental contamination, or the developability of the subject lands for any use intended by the Purchaser. No bid will be accepted where the bidder attempts to attach conditions precedent to the sale of any parcel. No terms and conditions will be considered other than those specified by the Village of Alliance. The Village of Alliance may, after the public auction, become the owner of any parcel of land not sold at public auction.
